Contributions are not deductible for federal income tax purposes. Federal Election Law requires us to report the name, address, occupation, and employer for contributions that aggregate in excess of \$200 in an election cycle. The maximum an individual may contribute is \$2,300 per election, with the primary and general elections treated separately. As a result, any initial contribution up to \$2,300 is designated for the primary and any additional amount is designated for the general, up to a total of \$4,600 per person. A couple may contribute \$9,200, designated per person in accordance with the preceding sentence. Federal multi-candidate PACs may contribute \$5,000 for the primary and \$5,000 for the general. Contributions from corporations, labor organizations, federal government contractors, and foreign nationals without permanent residency status ("green cards") are prohibited.
